All research and writing courses feature active and team-based learning strategies. Students engage with the text outside of class and use class time to work in groups to complete activities developed to test critical skills. Students meet one-on-one with professor more than four times a semester and receive both live and written feedback on practice assignments. Courses also highlight the importance of self-evaluation, which gives students a toolkit to transfer the critical skills learned in class into practice.
