THE BEACON PROJECT



The Beacon Project is a pro bono project launched in 2023 by LSASDV through which UNC Law students can assist in legal research to support the work of UNC Hospitals' Beacon Program, which provides trauma-informed, coordinated care services to patients experiencing interpersonal violence (IPV). Since the project's inception this academic year, students have engaged in research

projects on a variety of topics, such as legislative research on a proposal to mandate IPV education for physicians, research for a Title XI case regarding transcript withholding, research on child custody procedures for people experiencing IPV, and the creation of a one-pager in plain language on how to file for a Domestic Violence Protective Order in North Carolina.

New Project

NAME CHANGE CLINIC

This year, the UNC Pro Bono Board partnered with Equality NC to host a name change clinic, with the goal of helping LGBTQ+ folks in the local community navigate changing their name to affirm their gender identity. Over the course of one day at the Chapel Hill Public Library, 10 students and 5 attorneys helped explain the name change process and provide individualized support to 20 clinic attendees.

Special Projects

WINTER BREAK PROJECTS

Students have the opportunity to elect to work on pro bono projects specifically intended to be completed over winter break. These opportunities are especially valuable to students who have competing commitments or limited time during the academic year.

Over the course of the fall semester, the UNC Pro Bono Board solicits projects from attorneys and organizations, and students sign up for projects that interest them before winter break starts. Throughout winter break the students work closely

ATTORNEY PROJECTS

Attorney projects are pro bono projects that students work on during the course of the academic year. Attorneys and organizations who would like student assistance on pro bono work submit projects to the UNC Pro Bono Board, who connect them with interested students.

Attorney projects take all shapes and sizes, from 50-state surveys to researching novel legal topics to assisting in the drafting of motions for litigation. with their supervising attorneys to produce work that is helpful to the attorney, any clients, and the broader community. Winter break projects span over many practice areas, and the work completed by the student can be client-focused work, complex legal research, or anything in between.

EXPUNCTION PROJECT

Students continue to work with Legal Aid of North Carolina's Second Chance Project to assist clients seeking expunctions. This year, the project transitioned into a semester-long format, allowing students to be involved in the expunction process from beginning to end.

FALL BREAK

DEAR "Better Together" Expungement Project

This year, the UNC Pro Bono Program collaborated with Durham Expungement and Restoration (DEAR) for the second annual "Better Together" Project. As part of this project, student-volunteers had the opportunity to help complete expungement petitions in collaboration with participants from other Triangle-area law schools, namely Duke Law and NCCU Law.



For their work on the Better Together Expungement Project, UNC Law, Duke Law, and NCCU Law won this year's North Carolina Bar Association Pro Bono Committee's Law School Pro Bono Award.

Robeson County Wills Trip

In collaboration with Legal Aid of North Carolina (LANC), students had the opportunity to service a smaller, more rural community by traveling to Pembroke, North Carolina in Robeson County to assist clients at a wills clinic. Participants collaborated with attorneys and other students and gained practical experience in document drafting and client interviewing. The participating students served 8 clients from start to finish, executing 29 documents in the process.

SPRING BREAK

Safe Alliance Spring Break Trip

This year, the UNC Pro Bono Program collaborated in a new partnership with Safe Alliance, a domestic violence agency in Charlotte, N.C., and their Victim's Assistance Court Program. For the project, students traveled to Charlotte, where they assisted attorneys by reviewing clients' Complaints for Domestic Violence Protective Orders for sufficiency, prior to the Complaints being filed. Students were also able to attend domestic violence court at the Mecklenburg County Courthouse to better understand the process of obtaining a Domestic Violence Protective Order.

Alumni

This year, the Pro Bono Board held 6 "coffee chats" with alumni who are engaged in pro bono work as practicing attorneys. Students were able to learn about the day-to-day aspects of each alum's job and how each alum incorporates pro bono work into their job.



New Project

POP-UP PRO BONO

This Spring, the UNC Pro Bono Program provided students with a number of pop-up pro bono opportunities. This initiative sought to offer concise summaries of relevant cases from the NC Court of Appeals, intended to aid Pisgah Legal Services in case management and client support endeavors. Students were assigned new opinions released bimonthly, focusing on civil legal services, especially family law. With a cap of 10 participants per popup, the project ensured manageable engagement!

This year, the Pro Bono Program did just that through the power of partnership.

The Pro Bono Program was able to offer dozens of dynamic pro bono opportunities for students from an array of dedicated partners.
